Introduction

The findings of a recent study showed that there is a significant benefit to students who participate in out-of-school-time (OST) programs. In fact, the Return on Investment of Summer school Programs in Pennsylvania study determined that for every dollar invested in summer school programming for students there was a return of \$6.69 in potential benefits to students, including reduced rates for dropouts, teen pregnancy, substance abuse, crime and delinquency (Link PSAYDN.org).

In accordance with the American Rescue Plan (ARP) Act and Pennsylvania Act 24 of 2021 (Act 24), the Pennsylvania Department of Education (PDE) will award approximately \$50,000,000 or one percent (1%) of Pennsylvania's ARP Elementary and Secondary School Education Relief (ESSER) State Reserve funds to support school districts, charter schools and cyber charter schools (collectively, LEAs) in the development and implementation of comprehensive after-school programs to address learning loss in response to the academic, social, emotional and mental health needs of students and subgroups of students impacted by COVID-19 public health emergency that supplement school programs and activities.

Act 24 requires that, when available, existing personnel shall be utilized by school districts, charter schools and cyber charter schools to staff programs and activities established with these grant funds.

Within 90 days of receipt of these allocations, school districts, charter schools and cyber charter schools must submit a three- part plan to PDE, that outlines the proposed use of the grant money, itemized by program and activity. This plan is part of a consolidated application that includes after-school programming, summer programming, and a comprehensive plan to address learning loss. The plan shall include:

- 1) A description of each program and activity
- 2) A narrative outlining the expected benefit of each program and activity
- 3) A budget for each program and activity detailing personnel and operating costs

PDE has developed the Accelerated Learning Toolkit, a significant cadre of resources and trainings, to support LEAs in the development of their plans. The Accelerated Learning Toolkit can be found Link to Accelerated Learning Toolkit.

Indicators of Impact

During the Spring 2022 of 2023, a description of Titusville Area School districts summer programs will be shared, and an open enrollment period will take place. During Parent teacher conferences in March, parents will be targeted and encouraged to enroll their students in

summer school according to their academic performance in the first 3 grading periods. Credit recovery will be available for high school students, a form of credit recovery will also be available for Middle school students. For grades 6 - 12 there will be an in-Person credit recovery style program for Students who failed a course in the school year (Final Grade 40% - 59%), the courses will be open to Math, English, Science, Social Studies & Physical Education subjects only. Successful completion of a course will receive a pass (P) & credit for graduation purposes or a 60% at the middle school and promotion to the next grade level. Credit received is not factored into GPA or rank. A student will not be awarded credit if absent more than 1 day. Elementary programs will have Project Based weekly themes, have an emphasis on Math and Reading focus topic areas, include daily Integrated Science Music, Art, and STEM activities and target students identified as high skill deficit or high need of summer programming in order to retain academic skills.

A 2020 study conducted by the RAND group noted that there are 4 factors that make voluntary Summer Programs effective; Sufficient duration, Regular attendance, Quality instruction, and a positive climate. Evidence based resources that support Math, ELA and STEM instruction will be explored, reviewed and utilized by the summer program teachers. Our summer programs will be free of charge to all attendees, take place for at least 4 continuous weeks, will be held within our schools, have class sizes of 15 students or less, be taught by certified teachers focusing on 3 hours of academics per day with daily hands on enrichment activities as well. All programs will provide free transportation, breakfast and lunch to our students.
